**ENFORCEMENT ACTION FOR ALLEGED VIOLATIONS COMMITTED BY DBO OIL INCORPORATED (195858), AS TO THE CAMMY "B" LEASE, WELL NO. 4 (184481), DEANIE B. (JENNINGS SD) FIELD, THE CAMMY LEASE, WELL NO. 2 (170922), BEDDO FIELD, AND THE CAMMY (13643) LEASE, WELL NO. 2, DEANIE B. (JENNINGS SD.) FIELD, RUNNELS COUNTY, TEXAS**

**FINAL ORDER**

The Commission finds that after statutory notice the captioned enforcement proceeding was heard by the examiner on September 12, 2013, and that the respondent, DBO Oil Incorporated (195858), failed to appear or respond to the Notice of Hearing. Pursuant to § 1.49 of the Commission's General Rules of Practice and Procedure [Tex. R. R. Comm'n, 16 TEX. ADMIN. CODE § 1.49] and after being duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas, the Commission makes the following findings of fact and conclusions of law.

**FINDINGS OF FACT**

1. DBO Oil Incorporated (195858), ("Respondent"), was given Notice of Hearing by certified mail, addressed to the most recent Form P-5 (Organization Report) address, which was marked "unclaimed."
2. The certified receipt containing the First Amended Original Complaint and the Notice of Hearing, was returned to the Commission marked "unclaimed" on August 30, 2013. The certified receipt is included in the file and has been on file with the Commission for 15 days, exclusive of the day of receipt and day of issuance.
3. On April 15, 2009, Respondent, a Corporation, filed an Organization Report (Form P-5) with the Commission reporting that its officers consisted of the following individual(s): Andrew E. Orgon, President.
4. Andrew E. Orgon, was a person in a position of ownership or control of respondent, as defined by Texas Natural Resources Code Section 91.114, during the time period of the violations of Commission rules committed by respondent.

5. Andrew E. Orgon, was a person in a position of ownership or control of respondent, as defined by Texas Natural Resources Code Section 91.114, during the time period of the violations of Commission rules committed by respondent.
6. The violations of Commission rules committed by respondent are related to safety and the control of pollution.
7. Respondent designated itself to the Commission as the operator of Well No. 4 (184481) on the Cammy "B" Lease, Well No. 2 (170922) on the Cammy Lease and Well No. 2 on the Cammy (13643) Lease ("subject wells"/"subject leases") by filing P-4 Forms (Producer's Transportation Authority and Certificate of Compliance) effective on August 10, 2001 for the Cammy "B" Lease, Well No. 4, October 28, 1998 for the Cammy Lease, Well No. 2 (170922) and July 19, 1994 for the Cammy (13643) Lease, Well No. 2.
8. Respondent's P-5 (Organization Report) became delinquent on February 1, 2010. Respondent had a \$50,000 Bond as its financial assurance at the time of its last P-5 renewal.
9. Production from Well No. 4 (184481) on the Cammy "B" Lease ceased in March 2006.
10. Production from Well No. 2 (170922) on the Cammy Lease ceased in February 2008.
11. Production from Well No. 2 on the Cammy (13643) Lease ceased in December 1997.
12. The subject wells have not been properly plugged in accordance with, and are not otherwise in compliance with, Statewide Rule 14.
13. The Statewide 14b2 plugging extension for Well No. 4 (184481) on the Cammy "B" Lease was denied on January 30, 2009 for a non active P-5 status.
14. The Statewide 14b2 plugging extension for Well No. 2 (170922) on the Cammy Lease was denied on January 31, 2007 for a non active P-5 status.
15. The Statewide 14b2 plugging extension for Well No. 2 on the Cammy (13643) Lease was denied on October 2000 for a non active P-5 status.
16. Usable quality groundwater in the area is likely to be contaminated by migrations or discharges of saltwater and other oil and gas wastes from the subject wells. Unplugged wellbores constitute a cognizable threat to the public health and safety because of the probability of pollution.
17. The total estimated cost to the State for plugging Well No. 4 (184481) on the Cammy "B" Lease is \$15,900.00.
18. The total estimated cost to the State for plugging Well No.2 (170922) on the Cammy Lease and Well No. 2 on the Cammy (13643) Lease is \$15,900.00.

19. The Respondent has not demonstrated good faith since it failed to timely plug or otherwise place the subject lease and subject wells in compliance after being notified of the violations by the District Office and failed to appear at the hearing to explain its inaction.
20. Respondent has a history of commission rule violations including the following docket(s):

### **CONCLUSIONS OF LAW**

1. Proper notice was issued by the Railroad Commission to respondent and to all other appropriate persons legally entitled to notice.
2. All things necessary to the Commission attaining jurisdiction over the subject matter and the parties in this hearing have been performed or have occurred.
3. Respondent is in violation of Commission Statewide Rule 14(b)(2).
4. Respondent is responsible for maintaining the subject leases and subject wells in compliance with all applicable Commission rules according to Statewide Rules 14, 58, and 79 and Chapters 89 and 91 of the Texas Natural Resources Code.
5. The documented violations committed by the respondent constitute acts deemed serious, a hazard to the public health, and demonstrate a lack of good faith pursuant to TEX. NAT. RES. CODE ANN. §81.0531.
6. As a person in a position of ownership or control of respondent at the time respondent violated Commission rules related to safety and the control of pollution, Andrew E. Orgon, and any other organization in which he may hold a position of ownership or control, shall be subject to the restrictions of Texas Natural Resource Code Section 91.114(a)(2) for a period of no more than seven years from the date the order entered in this matter becomes final, or until the conditions that constituted the violations herein are corrected or are being corrected in accordance with a schedule to which the Commission and the organization have agreed; and all administrative, civil, and criminal penalties and all cleanup and plugging costs incurred by the State relating to those conditions are paid or are being paid in accordance with a schedule to which the Commission and the organization have agreed, whichever is earlier.

**IT IS ORDERED THAT** within 30 days from the day immediately following the date this order becomes final:

1. DBO Oil Incorporated (195858), shall plug the Cammy "B" Lease, Well No. 4 (184481), Deanie B. (Jennings Sd.) Field, the Cammy Lease, Well No. 2 (170922), Beddo Field, and the Cammy (13643) Lease, Well No. 2, Deanie B. (Jennings Sd.) Field, Runnels County, Texas in compliance with applicable Commission rules and regulations; and
2. DBO Oil Incorporated (195858), shall pay to the Railroad Commission of Texas, for disposition as provided by law, an administrative penalty in the amount of **FIVE THOUSAND DOLLARS (\$5,000.00)**.

It is further **ORDERED** by the Commission that this order shall not be final and effective until 20 days after a party is notified of the Commission's order. A party is presumed to have been notified of the Commission's order three days after the date on which the notice is actually mailed. If a timely motion for rehearing is filed by any party at interest, this order shall not become final and effective until such motion is overruled, or if such motion is granted, this order shall be subject to further action by the Commission. Pursuant to TEX. GOV'T CODE § 2001.146(e), the time allotted for Commission action on a motion for rehearing in this case prior to its being overruled by operation of law, is hereby extended until 90 days from the date the parties are notified of the order.

All requested findings of fact and conclusions of law which are not expressly adopted herein are denied. All pending motions and requests for relief not previously granted or granted herein are denied.

Noncompliance with the provisions of this order is subject to enforcement by the Attorney General and subject to civil penalties of up to \$10,000.00 per day per violation.
