Therefore, it is **ORDERED** by the Railroad Commission of Texas that the application of BP America Production. Co., for exception to Statewide Rule 28 requiring semi-annual G-10 well tests, is hereby **GRANTED** for all gas wells in the L.C.G. (Page) Field. No G-10 deliverability test shall be required in the L.C.G. (Page) Field while the allocation formula is suspended. Upon reinstatement of the allocation formula, the G-10 deliverability testing for the L.C.G. (Page) Field shall be performed annually from October to December.

All other requirements of Statewide Rule 28 shall remain in effect.
